Thus the **nonwoven grade in various grammages and embossing patterns** according to the sample material submitted may be used safely for the manufacture of towels and wipers which are used in the food preparing and processing industry as well as in the hygiene sector for cleaning. The towels and wipers manufactured with it may come into direct contact with foodstuffs as well as with the human skin and the mucous membranes for a short period of time as far as the mentioned nonwoven grade is concerned.

This certificate of compliance has a validity of 2 years and consists of 4 pages.
